



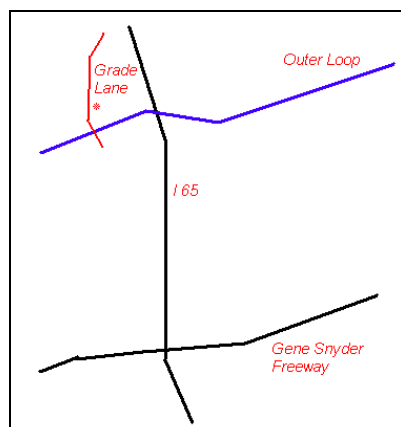
Hazardous Materials Disposal Reference Guide For Homeowners

How can homeowners dispose of hazardous materials?

Most homeowners have no way of easily disposing of hazardous materials, or are even aware that some household waste is termed hazardous and should be disposed in a way other than the regular trash pickup. Homeowners should be aware that in the Louisville/Metro Area, Kentucky, [a specialized hazardous waste disposal area has been designated for homeowner's use, free of charge](#). All that is required to use the hazardous waste disposal area is a valid driver's license showing that the homeowner is a resident of Jefferson County, Kentucky. This area and service has been named HazBin.

Items Accepted at HazBin

Asbestos floor tiles
Automotive fluids
Batteries (auto, household, rechargeables)
Cleaners (bathroom, rug/upholstery)
Driveway sealers
Fertilizers
Fluorescent light bulbs
Furniture polishes and waxes
Gasoline (including for boats)
Hearing aid/watch batteries
Kerosene
Lawn/Garden Chemicals (haz)

Mercury thermometers	Pesticides, herbicides
Metal polishes	fungicides, insecticides
Mildew removers	Propane Tanks (1 & 20 lb)
Mineral spirits/turpentine	Solvents/degreasers
Mothballs	Swimming pool chemicals
Nail Polish Removers	Varnishes and Stains
Oil-based or lead paint	Wood Preservatives
Oven and Drain Cleaners	

Items NOT accepted at HazBin

Containers of materials larger than 5 gallons or 40 pounds
Radioactive Materials (including smoke detectors)
Fire Extinguishers
Freon®
Latex Paint



*To properly dispose of fire extinguishers and smoke detectors, call the manufacturer and follow their instructions.

For bulk wastes, homeowners can use the Louisville/Metro Waste Reduction Center:

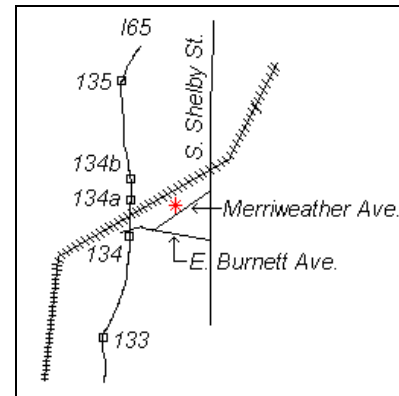

| Furniture & appliances* | Unbagged yard waste |

*Up to 3 large items are free. After 3 large items, a fee is charged per size of the vehicle.
